Ethos Ares has been tested to and complied with AS/NZS2918:2001 Test report # ARS 05/1254

FEI high temp fibreglass batts should be fitted around firebox casing to insure optimum performance.

note: It is essential the FEI batts do not obstruct the air intake spigot around the flue. The 200mm starter liner must be fitted

to prevent this happening.

FEI fibreglass batts must be fitted securely between the firebox casing and the opening of the open fireplace to prevent combustion air being drawn from the room into the fireplace cavity.

Flue kit: Ethos wood fires must be fitted with the Ethos factory flue kit as this has been specifically designed

to achieve optimum performance of the unit. It must be a minimum of 4.2 mtrs.

Seismic restraint: Use 2 x 6mm dynabolts or similar, two holes are provided in the front of the floor of the firebox

cabinet for this purpose.

Mantle: If a combustible mantle is within 930mm of the top surface of the hearth it must be protected with an

approved non combustible mantle deflector. Combustibles may touch the sides of the Ares fascia.

Flue shrouds: 200mm x 1200mm sheet metal flue shroud can be fitted where required. If the chimney size or

structure does not allow this, the sheet metal shrouds may be omitted as the chimney itself will become the shroud. Ethos wood fires have been safety tested with and without the shrouds fitted.

The 200mm x 200mm starter liner should always be fitted.

Floor protector: The floor protector must extend 200mm each side of the door opening. See graph on page 2 for

measurements required.
